### Overview

#### How to register a deal

#### 1. Register the opportunity

To access Deal Registration, click on the "Partner Central" tile upon logging in the

<u>RUCKUS Partner Portal</u>. Complete the form with the following:

- End user information (such as company name, address and contact)
- Project information (such as description, size, etc.)
- Products (RUCKUS Wired and/or Wireless products by SKU—not product family)

#### 2. Await approval

If the deal is approved, an approval notice will be sent from the system. The deal is protected for six months. Only one solution provider may receive an approved Deal Registration per customer opportunity.

Deals are generally approved/rejected within two business days of submission.

#### 3. Bid deal with Deal Registration discount and win!

## Program discounts

Incremental Deal Registration discounts may be provided, in addition to any standard discount solution providers receive from distributors. Pricing to solution provider is set by distributor. - All opportunities must be submitted via the Deal Registration tool and all required information must be submitted accurately for consideration. CommScope reserves the right to reject any registration submission.
- CommScope reserves the right to approve or reject any Deal Registration submission at its sole discretion.
