Pursuant to ASX Listing Rule 17.1, Dicker Data Limited (ASX: DDR) (Dicker Data) requests an immediate trading halt be granted by ASX Limited with respect to its shares from the commencement of trading on Tuesday 30 August 2022.

The trading halt is requested in connection with a capital raising.

The following information is provided in accordance with Listing Rule 17.1:

- 1. **Reason for trading halt** to avoid trading taking place on an uninformed basis and to allow the capital raising to take place in an orderly manner.

 - (ii) the commencement of normal trading on Thursday 01 September 2022.
