

Comparing the previous Azure offer and the new Azure offer (Azure plan) in CSP

When a partner transacts the Azure consumption services for a customer within CSP they may currently choose to transact via either the previous Azure offer or the Azure plan. This document compares these two offers.

Margin/Partner Earned Credit	Partners are invoiced at a standard discount off the list price, to provide a margin	Partners with admin access to Subscriptions are eligible for Partner Earned Credit which is taken off the amount due on the invoice
Incentives	Partners enrolled in the CSP Incentive program are eligible for a Core Incentive, which is a percentage of the Azure Consumed Revenue (ACR)	Partners enrolled in the Microsoft Commerce Incentive program are eligible for a Core Incentive, which is a percentage of the Azure Consumed Revenue (ACR)
